

TO TOLL DATE FOR EXECUTION AND FILING
OFFER OF FINANCIAL ASSISTANCE**

Robert Alan Kemp, D/B/A: NEVADA CENTRAL RAILROAD Hereafter ("Kemp" or "Petitioner"), files the instant request/motion to toll the 10 day period for which to execute and file an offer of financial assistance for an additional 30-days, commencing retroactively on August 15th, 2008 and ending September 14th, 2008, and for the following reasons.

1. Petitioner Kemp is in the process of moving his office from Reno, Nevada to Tempe, Arizona, and has not received notice of the Board's decision in this docket via US mail. Moreover, Petitioner just discovered the decision of the Board entered August 5th, 2008 on August 28th, 2008, as a result of accident while checking the STB internet site for publication of Petitioners Request/Motion for Substitution filed earlier the previous night on August 27th, 2008 via emergency fax and US mail some 2 days past August 25th, 2008.
2. Petitioner Kemp will establish contact with the Union Pacific Railroad Company on Tuesday, September 2nd, 2008, in order to coordinate the receipt via courier of UP's condition report to a physical location in either Phoenix or Tempe, Arizona.
3. Granting this Petition is in conformity with 49 USC ss 10101 (7) [reducing regulatory barriers to entry into the industry]; (13) [to ensure the availability of accurate cost information in regulatory proceedings; (15) [to provide for the expeditious handling and resolution of all proceedings]. Granting this Petition would not significantly adversely affect UP's ability to exit the industry along this line, for UP has not indicated that it intends to immediately salvage the rails then sell the real estate

4 WHEREFORE, Petitioner requests the time period within which to file an OFA be extended by 30-days until September 14th., to enable petitioner to evaluate date received from UP and then prepare and file a qualified OFA.
