**APPLICANT'S SUPPLEMENTAL SUBMISSION
IN RESPONSE TO OCTOBER 21, 2004 BOARD DECISION**

Pursuant to the request at page 4 of the Board's October 21, 2004 Decision in this proceeding, Applicant Tongue River Railroad Company, Inc. ("TRRC") hereby submits the attached chart reflecting its current ownership structure. The structure shown on that chart reflects the ownership of TRRC, Inc. as described in the April 25, 2003 verified statement of Mr. Mike T. Gustafson submitted with Applicant's May 1, 2003 Supplemental Evidence, with one exception, described in the next paragraph.

On October 16, 2003, WesRail, Inc. (a general partner of Transportation Properties LLP) was dissolved and replaced by WesRail LLC, a Montana limited liability company. All of the interests of WesRail, Inc. were assigned and transferred to WesRail LLC at that time. WesRail LLC (like its predecessor, WesRail, Inc.) is the sole member of Railco LLC, the other general partner of Transportation Properties LLP. Wesco Resources, Inc., previously the sole owner of WesRail, Inc., is the sole owner of WesRail LLC.

The Board's October 21 Decision also requests, at page 4, that TRRC submit a chart laying out the relationship, if any, between TRRC and its controlling entities with industries to be served by the TRRC line. No chart is submitted with herewith because there are no such relationships.


