





THIS TERMINATION OF MEMORANDUM OF DEMISE CHARTER INTENDED AS SECURITY is made as of March 20, 2008 by Chase Equipment Leasing Inc (herein "Lessor") and **Bunge North America, Inc. (f/k/a Bunge Corporation)** (herein "Lessee").

WITNESSETH:

WHEREAS, Lessor and Lessee are parties to that certain Memorandum of Demise Charter Intended as Security (herein "Agreement") dated as of October 20, 2000, which has been recorded with the Surface Transportation Board (the "Board") on October 20, 2000 under Recordation Number W59; and

WHEREAS, the duties and obligations of the parties to the Agreement have been satisfied and discharged with respect to 25 barges numbered BUNGE 13000 - BUNGE 14011 inclusive (herein combined as "Equipment").

NOW, THEREFORE, in consideration of the promises and covenants in the documents set forth above by reference, and for other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and the authority to issue and execute this document, intending to be legally bound, and recognizing the need to officially terminate the Agreement of the Equipment in the files of the Board, Lessor and Lessee hereby terminate and cancel the Agreement as of the date herein first written above; provided that this termination does not apply to provisions of the Agreement stated to survive such termination.


